Minutes of the Planning Committee Meeting of held on Monday 19<sup>th</sup> June 2017 in the Barbour Institute at 7.30pm

Access to the public, lack of space for children to play during out of school hours. Conservation Area and the Neighbourhood Plan were also mentioned. The Chairman informed them that the Parish Council and Ward Cllr. Mike Jones are meeting CW&C, School Governors next week when all these points will be covered with a hope that there can be some kind of compromise.
